139/19 Chairman's welcome and to receive apologies and approval of absences – The Parish Chairman welcomed everyone present to the meeting and wanted to give his thanks to the volunteers and parishioners who had erected the two wonderful Christmas trees in Sheepy Magna and Sibson, he also gave thanks to the businesses who had donated the two trees.

Apologies were received from Cllr Clive Stretton, Cllr Andrea Johnson and County Cllr Ivan Ould OBE

140/19 Declarations of interest and request for dispensations – Cllr Brian May stated he is heavily involved with Sibson Village Hall and does not want to take part in the discussion over the request for donation the Parish Council has received from the Village Hall in Sibson.

141/19 Parishioners Open Forum – During parishioners open forum the following items were discussed:

- A representative from Sibson Church gave an overview of their issues regarding the existing
 maintenance of the church grounds, they are seeking help from the parish council with
 regarding future maintenance. The Parish Clerk confirmed the existing maintenance contract
 is up for renewal and will ascertain if the Sibson Church grounds can be included in the
 schedule of works.
- Could Streetlights be installed past the new developments on the way to Twycross. This is a Highways matter and will be passed onto Leicestershire County Council.
- The grass is growing over the public footpath between the school and San Giovanni's in Sheepy Magna. The Parish Clerk will pass this onto the highway authority.
- A parishioner asked how the Parish Council is going to respond regarding the revised planning application for Gate Cottage in Church lane Sheepy Magna. It was stated this was on the agenda and will be discussed then.
- It was asked if the Parish Council could donate funds to the Primary School in Sheepy Magna, the Parish Clerk felt this would not be possible but would check the correct ruling.

- A parishioner asked what the Parish Council could do about the speeding in the Parish and could chicanes be installed in Sheepy Magna. The parish Council responded with the following:
 - Chicanes or any other traffic calming could not be installed as Main Road in Sheepy Magna is a designated HGV route.
 - The parish council had previously lobbied Leicestershire County Council and successfully got the speed limit reduced to 30mph along Man Road by the primary school.
 - The vehicle activated sign has been successfully used to collate data on speeding throughout the parish which can be shared with Leicestershire County Council, the sign also slows vehicles down when it is in use.
 - Sheepy Magna is now on the Traffic Camera Enforcement Unit list of places to monitor and prosecute speeding motorists, the vehicles will be visible on a regular basis along Main Road.
 - Highway planters are to be installed at the two areas where speeding has been recorded the most, Twycross Road Sheepy Magna and A444 Sibson.
 - The Parish Council are actively trying to join the Community Speed Watch Scheme, this will happen when there are places available in March 2020.

142/19 To approve the minutes of the meeting held on 5th November 2019– The minutes were signed as a true and correct record.

143/19 Clerk's report

- a) Fitness Equipment Sheepy playing fields –The installation of the equipment has now been completed, we are awaiting confirmation as to when the footpath is to be installed. This will take place once the ground conditions have improved. We are also obtaining quotes to cover the ground around the equipment with a harder surface to hopefully assist with the waterlogged conditions.
- b) Website The contract has been forwarded to the website provider and the Parish Clerk is awaiting the return of the signed contract documents. Action – Parish Clerk to chase website provider.
- c) Defibrillators The new defibrillator has been dispatched and will need to be installed onto the wall of Sheepy Memorial Hall. A defibrillator awareness session has been arranged for Tuesday 7th January, this is to take place just before the monthly Parish Council meeting. Action – Parish Clerk to arrange installation of the new unit.
- d) Church Mews This footpath will be filled with surplus stone from the construction of the new path for the outdoor gym. **Action** *Clerk to confirm when completed*.
- e) Pavilion The Parish Chairman stated that they had received responses about the proposed sub-committee from:

- f) Community Response Plan The Parish Clerk forwarded the completed template to all the councillors present and asked they forwarded any comments to him before the next meeting. **Action** Councillors to forward any comments they may have to the Parish Clerk.
- g) Sibson Heating and Street Lighting Cllr Brian May stated he was waiting for more quotes for the new heating in Sibson Hall. He is hoping they are forthcoming so he can apply for funding from the Parish and Community Initiative Fund. Applications for this funding will be accepted from October to February. The Parish Clerk had received confirmation from Hinckley and Bosworth Council that the heritage lights have now been ordered. **Action** Cllr Brian May to chase up heating quotes, Clerk to seek update on the heritage street lights
- h) Action plan The Parish Councillors agreed that the Action Plan should commence on the 1st January 2020. Cllr John Ward agreed to form part of the grants and donations committee.
- i) Christmas tree and Lights The Bonfire Society have received no objection from residents to their proposal to install Christmas lights along Main Road in Sheepy Magna, due to timescales it is unlikely the installation would take place this year.
- j) Councillor Vacancies Unfortunately during the month Cllr Johnathan Collett and Cllr Jessica Gurley Ward have both resigned. Notices for an election have been posted. Action – The Parish clerk is to call for expression of interests after the completion of the notice period.

144/19 Reports:

- a) County Councillor report this had been circulated, no comments or questions raised. Borough Councillor Report – No report received. Cllr Johnathan Collett gave an overview of the shortfall of housing development facing the Borough Council, Sheepy should be well placed because of the now made Neighbourhood Plan. He also raised his concern over the closure of the Cock Inn at Sibson, this is a building steeped in history and everything should be done to see it reopened. There is a facebook page set up to help with this and he will forward all the details to the Parish Council.
- b) **Police & Crime figures** –No monthly Police newsletter had been received, no update received from the Neighbourhood Watch.

145/19 Litter and Footpaths

- a) No new volunteers have come forward to assist with the litter picking, an advert is to be
 placed in the Gazette calling for volunteers. Action The Parish Clerk is to arrange the
 advert
- b) 10 Highfield Close footpath The sub-committee have contacted Leicestershire County Council who have stated if the land was sold to the residents the money could not be used to construct another footpath at the end of Brookside Place leading to the playing field. They also stated that the footpath could not be stopped off if there is any objection to it, which we already know there would be. The Sub-committee would like more time to gain more quotes for the construction of the footpath and to feed back at the next Parish Council meeting. Action – Sub-committee to report back at next meeting.
- c) Roadway to Sheepy Playing Fields The highway authority have been asked to resurface the full length of the footway, they have however circled with yellow paint all the pot holes ready to be filled. Action Parish Clerk to email Highways Authority again to state this is not good enough. If needed County Councillor Ivan Ould OBE would be a good contact to get involved with this issue.
- d) Footpath to Cemetery The councillors agreed that this is unlikely to go ahead as no funding will be available and it would be difficult to get landowners to agree to land transfer. The Parish Council will be better directing parishioners to the Good Neighbourhood Scheme in the parish, who could give parishioners a car ride to the cemetery as and when required. Action Parish Clerk to remove from agenda.

146/19 Speed Awareness/Vehicle Activated Sign

- a) Highway Barrel Planters The legal documents have been received these will be signed and sent back to the Highway Authority at Leicestershire County Council. Once the signed copy has been received back the Parish Council can decide on the size and style of the planters.
- b) VAS The camera has been turned round on Main Road in Sheepy Magna and is providing good information.
- c) Community Speed Watch The Parish Council have been informed they cannot take part in this scheme until March, when hopefully there will be some availability. **Action** *This is to be took off agenda until March/April*.

147/19 Ground Maintenance Update

- a) Wildflowers –. The request for wildflowers has been submitted to Leicestershire County Council there has also been a few landowners come forward to have new trees planted on their land. More wildflowers have been planted in the glade with the permission of the Sheepy Playing filed association.
- b) Maintenance Contract and Sibson Church The existing contract is up for renewal at the end of March, the documents had been circulated to ClIr Ian Papworth and ClIr Mick Toogood who have agreed to work with the Parish Clerk to update the documents before going out to tender, the document will be updated to include the works requested at Sibson Church. Action Comments to be sent to the Parish Clerk to update the documents.
- c) Flood Warden The Parish Chairman has been told by the existing Flood Warden he will soon be looking to step down from his role. Cllr Kate Gardiner has kindly circulated the
