A parishioner expressed an interest in becoming a Parish Council and was attending to see what is involved. The Parish Chair thanked them for their interest and asked if they would like more information then to contact the Parish Clerk at the normal email address.

Cllr Diana Whitley outlined concerns that there had been more fly tipping along Tinsel Lane and whilst it was cleared quickly the Parish Council will need to keep an eye on the situation.

Wellsborough parishioners have asked how easy it would it be to close the layby next to the Wellsborough war memorial as residents believe it is being used as a look out for robberies on Hornsey Rise. Cllr Josh Melen stated he would investigate. **Action** – Cllr Josh Melen to investigate this issue and report back at the next Parish Council meeting.

Cllr Clive Stretton reported from the Sheepy Memorial Committee, that the hire of the venue will need paying by the Parish Council. **Action** - *Cllr Clive Stretton to ask the committee to raise an invoice and send it to the Parish Council.*

He also asked, on behalf of the Memorial Hall Committee, if the Parish Council could repair the light in the Memorial Hall Car Park. **Action** – *The Parish Clerk to arrange for the light to be repaired*.

The minutes were considered and approved subject to re wording of the .gov.uk adoption discussion, where the decision was for the Parish Clerk to obtain further information from the website provider. **Action** – *Parish Clerk to amend the minutes and to contact the website provider.*

48/25 Reports

a. County Councillor -

Once again, it has been a pleasure to represent you all at County Hall during my second month in post. The last month has been quite eventful both in terms of casework and civic duties, as I attended a number of events to represent our area.

The first such visit was to the licensing service on 1st June for the new Revd. Paul Betts, now responsible for the Market Bosworth Parish churches. It is my understanding that eventually with the new 'Minster Communities', Revd. Betts will likely be responsible for the Sparkenhoe West area which broadly reflects the Market Bosworth electoral division. I will look forward to working alongside Revd. Betts during this period of change.

On 10th June, I attended Twycross Zoo for their annual Neighbours Event. This was an opportunity to understand the continued conservation work at the Zoo and I was able to raise concerns over traffic queuing with the CEO, Craig Dunkerley. I am told that queue prevention measures are being implemented internally on the Zoo site during busy periods which should help prevent traffic build-up on the A444. I will continue to monitor this alongside Twycross Parish Council over the holiday period.

By the time this report has been published, I will also have attended the Armed Forces Day parade on 28th June and a visit to MIRA on the morning of 2nd July. Both of these events will feature in my next report. In terms of County News, we continue to lack specific policy information from the Reform administration although this may change after the full Council meeting on the 2nd. The cumulative effects that we are aware of so far are changes to the flag policy at County Hall and cuts to LCC organised classes such as the pottery group. I have been contacted by residents concerned about the latter cuts and will continue to advocate on

their behalf. Residents across the division have also expressed concerns about the changes to bus services.

I will know more on this issue after the full Council meeting, but I understand that 'FoxConnect' will be made available throughout the County. My current understanding is that the present regular bus services will remain, and this 'dial-a-ride' style service will supplement the more remote areas of the division. I will continue to report on any changes in due course. As always, if there are any queries relating to the schedule below, please contact me at joshua.melen@leics.gov.uk. I will continue to advocate for your Parish throughout July and will work to resolve your local issues to the best of my ability.

Sheepy Activities.

Highways safety assessment requested at the Pinwall junction following developments at Smith's garage and housing at the Red Lion pub. Chased with Highways given expected imminent site opening.

Ongoing dialogue with LCC officer responsible for planning application at Glebe Farm, Sibson. No resubmission from applicant yet.

b. Borough Councillor - Cllr Miriam Surtees and Cllr Brian Sutton outlined the updates from the Borough Council; there has been very few meetings taking place and is currently very quiet until the next full council meeting on 3rd July. The few updates are:

Dame Carol Black will be receiving a blue plaque and freedom of Hinckley

The Scrutiny Task force and finance committee have identified that instead of spending £1 million in re housing residents in private accommodation they will look to purchase 20 new permanent homes in and around Hinckley that can be used for future re housing.

Safeguarding the future of Cineworld as seen the footfall through the doors increase by 8% the highest in the region, new initiatives including golden oldies day and cheap children's tickets

13 houses awarded to Hinckley ad Bosworth Borough Council from the new developments in Market Bosworth that will be used as council housing.

The new junction on the A444/A5 as part of the MIRIA expansion is still not going ahead.

Devolution costs seem to be spiralling, and the scrutiny panel has been suspended whilst the papers are being evaluated.

Data Archive – The Parish Clerk outlined the need for the Parish Council to seek a supplier who could archive and scan the old parish council paperwork as there is no room in the Memorial Hall to store any more files. **Action** – *Parish Clerk to obtain costs to convert data and have it archived*

Parish Forum Feedback – Cllr Josh Melen and Cllr Diana Whitley recently attended the Parish Forum held at Market Bosworth and feedback to the Parish Council, the minutes and slides from the forum have been circulated to all councillors. The main areas discussed were:

Police – The radar gun has been out and about and used more, there is an issue with not reporting crimes and the rural beat team is now back up to full capacity.

Devolution Workshop Feedback – Cllr Kate Gardiner recently attended a workshop on the devolution of the County and feedback to the Parish Council, she also circulated slides from the workshop which the councillors were asked to review. This workshop was based around Hinckley and Bosworth's Borough Councils proposals on devolution and felt more like a consultation than a workshop which was not how it was advertised. Cllr Kate Gardiner reminded the Parish Council that parishioners have already been asked to make their comments to Hinckley and Bosworth Borough Council with a closing date of 20th July. **Action** - *Parish Clerk to re advertise this consultation deadline on the Parish website and social media*

LCC Connect Feedback – The Parish Clerk attended the workshop held by Leicestershire County Council at Hinckley Library regarding the changes to the bus service in the Parish. The changes are coming in from the 14th July with the new Fox connect service being used in the Parish, the full details of this implementation and what this means to the bus service were not fully known but will hopefully be shared shortly. The Fox connect team agreed to come to the Parish to demonstrate the system and answer any questions. It was agreed they would come to the coffee morning at Sheepy Memorial Hall on 30th July and they will send through a poster advertising this event. **Action** – *Parish Clerk to place advert on website etc when received*

50/25 Parish Initiatives

ACV Cock Inn – Cllr Josh Melen gave an update on the application, he has received a few completed questionnaires from local groups and has passed them onto the Parish Clerk, he is waiting on a few more which he will forward onto the Parish Clerk once received so the application can be re submitted. **Action** – Cllr Josh Melen to forward all the completed information ASAP to enable the Parish Council to re submit the application

Sibson Plaque – The Parish Clerk has received the paperwork for the licence so the plaque can now be installed. **Action** – *Parish Clerk to liaise with the Sibson parishioners to obtain quotes to get the plaque installed*

Road Safety – There is still one vehicle activated sign to be installed in Sheepy Parva which will hopefully be installed before the next Parish Council meeting. There has still been no communication from the Community SpeedWatch team and the Parish Clerk has chased them up for a reply.

Newsletter – This is still being drafted and will be circulated to councillors once a draft has been finalised.

Beacon – The Parish Clerk has received communication from the Beacon Society which will need to be circulated to all councillors for discussion at next month's meeting. **Action** – *Parish Clerk to circulate the communication from the Beacon Society to all Parish Councillors so it can be discussed at Augusts Parish Council meeting with an invitation for a representative of the society to attend.*

Sale of MVAS – Now that the new vehicle activated signs have been installed, the Parish Clerk asked the Parish Council if they were willing to sell the two existing units to another Parish Council as he has had interest from Stoke Golding Parish Council. It was discussed and agreed that a "contribution" should be made for the units. Cllr Josh Melen stated he would be at their Parish Council meeting later in the week and would discuss further with them and feedback. Action - Cllr Josh Melen to discuss with Stoke Golding Parish Council and feedback

Electronic Banking – The Parish Clerk confirmed that the new bank account is now set up and the transfer date was set as the 11th July. Before this date the existing savings account balance needs to be transferred to the existing current account so it could all be transferred over in one transaction and then split into the new accounts after the transfer date. The Parish Clerk asked if one of the authorised signatories could accompany him to the bank to carry this out before the transfer date. Cllr Rob Ward agreed to do this with the Parish Clerk. The Parish Clerk also stated he would update the financial regs to reflect the electronic banking system once the process was fully understood. **Action** - *Parish Clerk and Chair to visit existing bank and transfer savings funds into current account funds before 11th July.
